

# REPORT OF THE SUBCOMMITTEE on ELEMENTARY & SECONDARY EDUCATION

Mr. Chairmen and Members of the Committee:

The Elementary and Secondary Education Subcommittee is pleased to put before you a series of recommendations that continue to offer choices of flexibility to our school divisions in order to meet the financial challenges they face as the economy begins to show some initial and hopeful signs of recovery.

Before I get into the specifics of the Subcommittee's recommendations, I am very pleased to be able to share with you some impressive outcomes that Virginia's students have accomplished.

As some of you may recall, Dr. Wright, the State Superintendent of Public Instruction, shared with the subcommittee several weeks ago that *Education Week* ranked Virginia the fourth best school system in the nation for education policy and performance in its 2011 Quality Counts report.

Our students also are among the highest-achieving in the nation on Advanced Placement tests and on SAT and ACT college-entrance examinations. In 2009, almost 23% of the Commonwealth's public high school seniors earned a grade of 3 or better – qualifying for college credit – on at least one Advanced Placement examination. There were only two states, New York and Maryland, which had higher percentages of seniors earning grades of 3 or better on AP tests.

Furthermore, the results from national reading tests taken last year has shown that Virginia elementary and middle school students continue to outperform their peers nationwide and rank second in the nation on the fourth-grade reading test.

Clearly, the report's findings show that Virginia continues to be a national leader in quality education and provides numerous opportunities that result in a high level of success for our young people.

Now, Mr. Chairman, I'd like to turn to our recommendations.

As I mentioned a moment ago, the Subcommittee's top priority was to provide more flexibility to our school divisions that would help them manage their budgets and that will ensure dollars are focused into the classroom.

To that end, included in our recommendations are a number of adjustments that will provide nearly \$66.0 million in state allocations to provide a 2% bonus for teachers. School divisions will be permitted to use their Education Jobs funding towards the local match. However, for those divisions that choose not to offer a bonus, these dollars can be used to purchase buses and textbooks or be used for other high-priority educational expenditures.

Mr. Chairman, as you pointed out in your remarks, it is incumbent upon all of us to increase funding for the Virginia Retirement System. However, we must strike the right balance between funding the VRS and ensuring that schools manage their budgets without further reducing classroom resources.

Our recommended action will take some immediate financial pressure off school divisions' budgets while ensuring an increase level of funding to the VRS. Specifically, the Subcommittee recommends a lump sum payment in fiscal year 2012 of \$89.8 million to the VRS which represents the state's share of a 3.3% contribution rate increase. While this will not have to be matched by the school divisions, it is important that they understand that they will be paying higher rates in fiscal year 2013, and should begin to budget for such increase.

Funding for this payment will come from redirecting the second year hold harmless funding and from funding elementary resource teachers at the level required by the Code of Virginia. The statute directs school divisions to hire elementary resource teachers for grades kindergarten

through the fifth grade. However, the budget funds resource teachers for grades K-7.

By having the state make this payment directly to the VRS, we are showing our commitment toward maintaining the financial soundness and future solvency of the retirement system, while saving school divisions an estimated \$105 million in local VRS-related costs they would have incurred in the Governor's introduced budget.


I now would like for Committee staff to explain each of the Subcommittee's recommendations in more detail. I hope it will be the pleasure of the Committee to adopt our recommendations.





These funds may not be used for any other school purpose. If a school division elects to reprogram any portion of the Virginia Preschool Initiative funds toward expanding the number of full-day and reducing half-day kindergarten classes, then the school division's total fiscal year 2012 Virginia Preschool Initiative funding shall be limited to the total fiscal year 2011 Virginia Preschool Initiative funding amount. Localities receiving these payments are required to match these funds based on the composite index of local ability-to-pay."

d. Localities receiving these payments are required to match these funds based on the composite index of local ability-to-pay. School divisions are permitted to use qualifying expenditures from the federal Education Jobs Fund for the purpose of meeting the required local match for this one-time state payment."

**Explanation:**

(This amendment provides \$65.7 million the second year from the general fund as a one-time supplemental payment to school divisions. These funds will be allocated to localities based on the state's share of a 2% bonus amount for all funded positions. School divisions can use these funds for (i) a 2% bonus for all eligible personnel; (ii) the purchase of additional textbooks; (iii) school buses; or (iv) for any other education purposes as determined to be needed by the individual school division. This amendment is intended to give school divisions additional flexibility with state and local matching funds in order to meet their specific local priorities and particular financial circumstances. Lastly, these funds must be used for one-time, nonrecurring purposes.)
