REPORT OF THE SUBCOMMITTEE

on

Commerce and Technology

Mr. Chairman and Members of the Committee:

For the past several weeks, the Subcommittee has been reviewing the budget before us and considering, what if any, changes in spending needed to be made in order to help restore funding for Committee priorities such as establishing a reserve fund and reopening the Department of Motor Vehicle offices as well as the priorities that the Subcommittee identified in the areas of Commerce and Technology. In that light, we have heard from state agency staff, Cabinet Secretaries, legislators, and citizens who work every day promoting agricultural and industrial development and information technology.

Mr. Chairman, Virginia has accomplished a great deal in the economic development and information technology arenas in the past decade. This accomplishment is clearly linked to the support you have consistently provided to this Subcommittee. Today, Virginia has a well-developed infrastructure designed to continue to build upon the great advances during the past decade, and not only in the area of high technology.

During this Session, the Subcommittee has examined the agencies and programs that are in our purview to begin the process of identifying programs and services in order to systematically and efficiently allocate our scarce resources. We recognize that in these times of fiscal constraints, we must scrutinize all of our spending and make difficult decisions, yet protect and, to the extent possible, nurture the activities that sustain our strong economic development and technology base.

Mr. Chairman, the framework we used to facilitate our review during this Session has resulted in reductions to some programs in this area. For example, the Subcommittee recommends that the Virginia Enterprise Initiative and the Business Incubator programs -- which were initiated during a period of extraordinary revenue growth -- be reduced in this budget. However, sufficient funding remains in both programs to carry out core functions. In addition, some economic development grant programs, such as the Solar Photovoltaic Grant program, were deferred until the next biennium when the Subcommittee will reevaluate their funding requirements.

It is important to note Mr. Chairman, that this program-by-program review also highlighted for the Subcommittee selected services and programs that the Subcommittee believes are important to the overall economy, business environment, and citizens of the Commonwealth. For example, the meat inspection program at the Department of Agriculture and Consumer Services is a service that is provided in an exemplary manner to 158 meat processing plants across the state that produce more than 80 million pounds of products annually. VDACS staff not only regulate facilities for safety and health issues, they provide plant owners and operators advice and assistance that improves efficiency and ultimately the final product. Given this, Mr. Chairman, it seems most appropriate to maintain a program that delivers top-notch service to the large and small businesses that we count on to help sustain and improve our economy.

In addition, Mr. Chairman, the Subcommittee's review concluded that the state's tourism industry is a key component of the state's economy. Moreover, this industry provides many wonderful opportunities for Virginia's own residents to enjoy the many cultural, historical, and tourist sites and activities within our great state.

More importantly, the upcoming release of the Civil War movie "Gods and Generals," which with your support was filmed

in-part on location in Virginia, will increase the exposure of Virginia's many Civil War historical sites and museums to families across the country. Therefore, to enhance our ability to build upon this exposure and to market all of our wonderful activities and sites, the Subcommittee recommends that \$1.0 million be allocated to the Cooperative Advertising Program at the Virginia Tourism Authority. Restoring this program will enable the Commonwealth to partner with local tourism organizations to build upon the interest in Virginia's historical sites and many tourist locations and activities as well as prepare for Virginia's 400th birthday celebration.

Mr. Chairman, our efforts to achieve specific budget savings while maintaining specific economic development programs have helped the entire Committee achieve its goals of re-opening the Department of Motor Vehicle's offices and providing a reserve that can be used to provide a cushion in case of a revenue decline or provide a much-needed salary increase for our hardworking public employees.

Mr. Chairmen and fellow Committee members, I will ask staff to take you through our detailed recommendations, and then I hope it will be your pleasure to adopt our subcommittee report.

2. The Authority shall contract with a third party, subject to approval by the Secretary of Commerce and Trade, to review the underwriting and pricing of the portfolio with the costs of such review to be paid by the Authority. In selecting the third-party reviewer, the Secretary shall take into consideration the candidates' experience in the underwriting, pricing or sale of community development loan portfolios.

3. The agreement shall set out the details of the transfer of the responsibilities and functions of the housing finance activities of the Department to the Authority. As part of the agreement, any residual balances from the sale of the Virginia Housing Partnership Revolving Loan Fund shall be transferred to the Authority to be used in conjunction with existing resources to provide affordable housing to low-income Virginians not currently served by existing Authority programs.

4. Before the execution of such agreement, the Secretary of Commerce and Trade shall provide the House Appropriations and Senate Finance Committees the opportunity to review the agreement. For this review, the Secretary shall also include information identifying the options and alternatives reviewed for carrying out the purposes of § 36-142, Code of Virginia, as well as the rationale for selecting the option incorporated in the draft agreement. In developing and assessing options, the Secretary shall consult with representatives of the housing industry, including the Virginia Housing Coalition.

5. The draft agreement submitted by the Secretary of Commerce and Trade shall also include the discount rate to be applied in calculating the market value of the loan portfolio, and other pertinent items.

6. Upon execution of the agreement, the Authority shall deposit the proceeds of the sale into the Virginia Housing Partnership Revolving Loan Fund. Notwithstanding the provisions of §§ 36-141 through 36.151, Code of Virginia, the Director of the Department of Housing and Community Development is directed to pay from the proceeds of the sale of the Virginia Housing Partnership Revolving Loan Fund in the amount of \$40,822,000 to the general fund prior to June 30, 2003."

Such fund shall be subject to the Uniform Management of Institutional Funds Act (§ 55-268.1 et seq.). The fund and the income from such fund shall not be subject to the provisions of § 2.2-1802. The availability of such fund shall not be taken into consideration in, nor used to reduce, state appropriations or payments, but such funds shall be used in accordance with the wishes of the donors thereof to offset the costs of conducting analyses of the availability and utilization of minority business enterprises or otherwise strengthen the services rendered by the Department to minority business enterprises in the Commonwealth. The Director, Department of Planning and Budget, is authorized to establish a nongeneral fund appropriation for the purposes of expending revenues that may be received for this program."

The Fund shall be established on the books of the Comptroller. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it. Any moneys remaining in the Fund at the end of each fiscal year, including interest thereon, shall not revert to the general fund but shall remain in the Fund. Expenditures and disbursements from the Fund, which may consist of grants or loans, shall be made by the State Treasurer on warrants issued by the Comptroller upon written request bearing the signature of the chairman or the vice-chairman of the Authority, or, if so authorized by the Authority, bearing his facsimile signature, and the official seal of the Authority, subject to any restrictions listed in Item 512 of this act.

b. Moneys in the Fund shall be used for the sole purpose of attracting public and private research funding for institutions of higher education, in order to increase technological and economic development in Virginia. Awards from the Fund shall be made to Virginia public institutions of higher education or to their associated intellectual property foundations.

2.a. For purposes of awards, the Fund shall have four components: (i) a matching funds program to leverage federal and private research dollars; (ii) a strategic enhancement program to upgrade the research capacity of those academic departments that have demonstrated the ability to perform innovative research in technology fields that has strong potential to contribute to economic development in the Commonwealth; (iii) a program to upgrade research capacity in key departments of the institutions in order to attract specific companies to locate or expand in Virginia; and (iv) a program to enhance the capability of the institutions of higher education to commercialize technologies developed through their research.

b. Awards for the matching funds component shall be contingent upon the approval of the institution's grant proposal for federal or private funds. Awards from the Fund shall be matched on at least a dollar-for-dollar basis by the respective institution of higher education, with private funds, or combinations thereof. However, for good cause, this requirement may be waived, in whole or in part, by the chairman of the Authority, provided that such action is reported to the Chairmen of the House Appropriations and Senate Finance Committees at least 10 days prior to the award or disbursement of such funds for such purpose.

3.a. Awards shall be based on the scientific merit and economic development potential of research programs in the following fields: aerospace, biotechnology, energy, environmental and information technologies, high performance manufacturing, telecommunications, and transportation. However, for good cause, awards supporting research in other relevant fields or disciplines may be made by the chairman of the Authority, provided that such action is reported to the Chairmen of the House Appropriations and Senate Finance Committees at least 10 days prior to the award or disbursement of such funds for such purpose.

b. Specific guidelines for the award of funds from this program shall be established and maintained by the Authority, in consultation with the Virginia Economic Development Partnership and the State Council of Higher Education. These guidelines shall address, at a minimum, the application process, and the composition and operation of proposal review panels, and give special emphasis to fostering collaboration between institutions of higher education and partnerships between institutions of higher education and business and industry.

c. The chairman of the Authority shall coordinate the evaluation of proposals, to be conducted by review panels with the appropriate science and technology expertise,

drawn from federal agencies and academic and industrial research institutions across the country.

d. Recommendations on the grants shall be made by representatives from the Virginia Research and Technology Advisory Commission pursuant to § 2.2-2515, the Virginia Economic Development Partnership, and the State Council of Higher Education based on the recommendations of the review panels.

4. The chairman of the Authority shall provide the Governor and the General Assembly with an annual report which shall include a detailed list of awards committed, the amount of each approved award, a description of the approved proposals, and the amount of federal or private matching funds anticipated where applicable, and an assessment of the effectiveness of the Fund in attracting public and private research funding and increasing technological and economic development in Virginia."
