

# REPORT OF THE SUBCOMMITTEE on SPECIAL PROJECTS

Members of the Committee:

The Special Projects Subcommittee reviewed project requests totaling \$225.4 million for historic landmarks and nonstate agencies. This included about \$23.3 million in specific capital requests.

This Committee has long recognized the value of these organizations to the Commonwealth. The investment of some state funds in these cultural attractions and educational organizations is a sound move that bolsters economic development and education in Virginia. Last year, we provided significant funding for these organizations for the first time in a number of years. Today, we once again have the available resources to provide funding for these cultural and educational organizations. Consequently, the Special Projects Subcommittee attempted to provide a similar level of funding this year as was provided during the previous Session. I am happy to report that we were able to recommend more funding for these organizations this year.

Therefore, we offer for your consideration total funding of \$40.2 million for historic landmarks and nonstate agencies. The

amounts recommended reflect our commitment to one-time spending in this budget. The recommended funding provides grants to 227 organizations.

In addition, the Subcommittee recommends redirecting \$4.5 million in grants awarded last year to the Virginia Performing Arts Center to other Committee priorities. The reason for this recommendation is the dramatic reduction in the project's scope and the removal of support for the project by many of its private sector financial backers.

I ask the Committee to adopt these recommendations.
