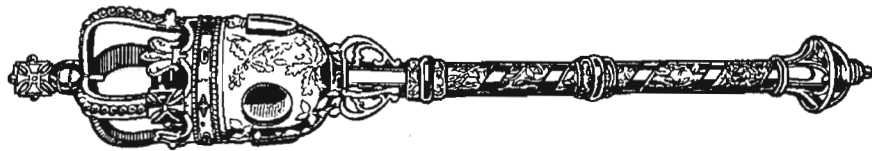

REPORT OF THE SUBCOMMITTEE

on

HIGHER EDUCATION

Mr. Chairman and Members of the Committee:

Mr. Chairman, the Subcommittee's recommendations today continue to reflect the course we charted in 2011 when we adopted the "Top Jobs" legislation. They reflect this Committee's consistent goals of increasing access for Virginia students, holding down costs for Virginia families, enhancing the quality of their education and improving their job opportunities.

The late, great New York Yankee manager, Casey Stengel once said, "I don't like them fellas who drive in two runs and let in three." With that in mind, the Subcommittee recommends nearly \$290 million in new funding for our public colleges and universities coupled with the expectation that those same institutions limit their in-state tuition increases for each of the next two years to no more than three percent. If I can digress for just a moment, this expectation should not be viewed as the decision point. Many institutions could and should do less. In fact, it would be good news indeed if some would simply look at breaking their "Promise" and perhaps lower their expected increases. I am sure that would make Mr. Jefferson a proud graduate.

The recommendations include \$127.4 million allocated to our public institutions to address their priorities of in-state enrollment growth, hiring new faculty, improving retention and supporting basic operations. Another \$44.0 million is recommended in the central accounts for a three percent faculty pay increase beginning December 2016. I want to thank Mr. Poindexter for his work on this issue. Mr.

Chairman, thank you for your leadership in making this possible for our hard working state employees.

The Subcommittee also recommends \$52.7 million in new financial aid funding. The second year of this funding is contained in the SCHEV budget with a call for reform of the financial aid methodology by the Higher Education Joint Subcommittee. Mr. Chairman, this Subcommittee heard several interesting ideas during session on how to lower the cost of college and how to best address student financial need. Reform of our nearly 40-year-old financial aid model is long overdue.

In addition to these funds, Mr. Chairman, the Subcommittee looked for ways to encourage and reward innovation and research at Virginia colleges and universities. To that end, the Subcommittee recommends \$40 million to support a new collaborative approach to research with a more focused eye on commercialization. Again, I want to thank the Chairman for spearheading this new approach in his bill which was unanimously reported by this Committee. In addition, this research initiative leverages the horsepower of the Virginia Growth Opportunity Board. This recommendation also includes \$50 million in VCBA bonds to allow for lab renovations and the acquisition of research equipment. Another \$10 million is recommended for cancer research at VCU (\$6 million) and noninvasive surgery research at UVA (\$4 million).


Looking beyond the four-year degree track, the Subcommittee is pleased to recommend \$12 million to support a new workforce training program to assist Virginia students in getting the necessary credentials to improve job opportunities in high demand areas.

The Subcommittee also recommends a pilot program at George Mason and James Madison for enhanced autonomy opportunities. In addition, \$4 million is recommended for continued development of


online course offerings by George Mason and Old Dominion Universities.
