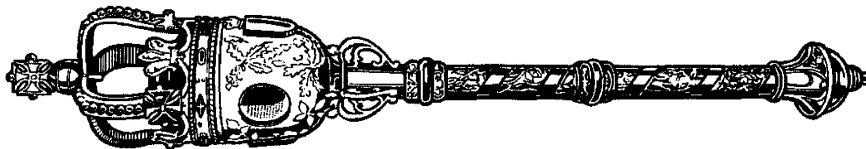

REPORT OF THE SUBCOMMITTEE

on

CAPITAL OUTLAY

Mr. Chairman and Members of the Committee:

On behalf of the Capital Outlay Subcommittee, I am pleased to offer budget recommendations that meet the Committee's priorities of limiting our tax-supported debt burden and maintaining the principles outlined by you, Mr. Chairman, in 2008, when under your leadership, we developed the Six-Year Capital Outlay Plan. You will recall your program intended for the legislature to become a partner in the development of long-range capital plans. Mr. Chairman, your program changed the way that we evaluate capital needs and brought sound business practices to the capital outlay area. This came about in a truly bipartisan fashion and was reported unanimously which speaks to the strength of the program. The Subcommittee's recommendations are intended to ensure that fidelity to that process be maintained.

Given our financial situation, the work of the Subcommittee was focused on reducing our tax-supported debt burden. As you know, Mr. Chairman, the introduced capital program called for \$240 million in new tax-supported debt. However, being mindful of the state's debt capacity, I am pleased to report that we have prioritized our projects and reduced overall tax-supported debt by \$96 million. This debt was proposed for 28 projects as supplements under the maintenance reserve program. However, given the size and scope of these projects, it is more appropriate that they proceed under the typical capital outlay process. As opposed to financing these projects with debt, we have reviewed all the high priority repair and infrastructure projects and propose \$27.5 million in general funds to move fifteen of these projects forward. As part of this recommendation, we are designating \$2 million to repair the Louisa County High School that was damaged in the August 2011 earthquake. You will recall, Mr. Chairman, that the Commonwealth stepped up to the plate to help the City of Franklin recover from flooding damage after Hurricane Floyd in 1999. This is no different.


Mr. Chairman, as I mentioned earlier, the Capital Outlay Subcommittee is committed to proceeding with a capital program that is consistent with the principles outlined in the 2008 legislation. The introduced budget proposed preplanning for 59 projects some which had already completed preplanning, such as the UVA Rotunda, and others which were projects that this Committee had previously rejected. With that in mind, the Subcommittee recommends eliminating the proposed preplanning contained in the introduced budget and proceeding in a manner that will provide meaningful detailed planning for 29 high priority projects which have been technically reviewed by the Department of General Services and, for higher education, programmatically reviewed by the State Council of Higher Education. The Subcommittee recommends using a total of \$31.2 million to accomplish detailed planning through preliminary and working drawings for these projects. The central planning fund will provide \$16.1 million of this amount, along with \$600,000 from the general fund and \$14.5 million from nongeneral fund sources. The nongeneral funds represent a cost sharing recommendation with colleges and universities for which they will be reimbursed.

The Subcommittee also scrubbed the budget for potential budget savings. We are pleased to recommend \$13.4 million in debt service savings in the Treasury Board that result from lower interest rates and revised debt issuance projected over the biennium. In addition, the Subcommittee recommends adjusting the out-of-state student capital fee by \$1.50 per credit hour or about \$45 per year. This recommendation, combined with updated enrollment data, saves the Commonwealth \$5.3 million.


Finally, Mr. Chairman, we are pleased to recommend \$28.5 million in general funds to construct a new Veterans Care Center in Hampton Roads. This represents the state share of 35 percent of the project cost. The federal Department of Veterans Services will provide the remaining funding.

- 1) the first payment of \$5 million on October 1, 2012;
- 2) the second payment of \$5 million on January 1, 2013; and,
- 3) the final payment of \$5 million on April 1, 2013."

"1. Subject to the provisions of this act, the General Assembly authorizes Norfolk State University to enter into a written agreement or agreements with a Foundation of the University for the development of one or more student housing projects on or adjacent to campus, subject to the conditions outlined in the Public-Private Education Facilities Infrastructure Act of 2002.

2. Norfolk State University is further authorized to enter into written agreements with a Foundation of the University to support such student housing facilities; the support may include agreements to (i) include the student housing facilities in the University's student housing inventory; (ii) manage the operation and maintenance of the facilities, including collection of rental fees as if those students occupied University-owned housing; (iii) assign students to the facilities in preference to other

University-owned facilities; (iv) restrict construction of competing student housing projects; (v) seek to obtain police power over the student housing as provided by law; and (vi) otherwise support the student housing facilities consistent with law, provided that the University shall not be required to take any action that would constitute a breach of the University's obligations under any documents or other instruments constituting or securing bonds or other indebtedness of the University or the Commonwealth of Virginia."

Notwithstanding any other provision of law, the following provisions shall be implemented:

1. The Director, Department of Planning and Budget, shall transfer \$2,500,000 of the amount appropriated in Chapter 879, 2008 Acts of Assembly, for project 17597 (Preservation of Open Space and Historic resources Through Conservation) for the Civil War Site Preservation Fund and expended in accordance with the purposes and requirements of § 10.1-2202.4 except that the funds shall be awarded only for the fee simple acquisition of battlefield lands for the benefit of the Commonwealth and its citizens.

2. In its expenditure of the funds, the Department of Historic Resources may give priority to the establishment of a public battlefield interpretive park to be located in a jurisdiction served by the Northern Virginia Regional Park Authority and operated by such Authority. The Department of Historic Resources may waive the match requirement of § 10.1-2202.4C in conjunction with the funding of such park.
