# **Process for Project Selection**

- Same capital needs list provided for HAC tour this summer was provided to Governor's Office
- Projects were chosen based on:
  - Taking care of aging infrastructure
  - Projects with greatest potential economic impact
  - New approach is proposed to provide full build out of two parks in this authorization
    - Full economic impact achieved sooner



- \$140 million proposed for State Parks in VPBA bond package
  - Proposed funding would focus on:
    - Development of 2 "land-banked" parks
    - Repair and maintenance of existing facilities
    - Construction of day-use facilities
    - Acquisition of additional land for existing state parks



### **Biscuit Run State Park**

- Albemarle County south of Charlottesville
- Approximately 1,195 acres
- Frontage on Routes 20 and 631
- Acquired in 2009
- Potential economic impact of \$6.6 million

#### **Proposed Development**

Revenue Generation

30-site campground 20 cabins (1-6 bedroom, 12-2 bedroom, 7-3 bedroom)

#### Infrastructure

Contact station, office/admin complex, maintenance facility, connection to public utilities, staff residences





#### Widewater State Park



- In Stafford County on the peninsula created by the confluence of Aquia Creek and the Potomac River
- Approximately 1,100 acres
- Water frontage on both the river and the creek
- Acquired from Dominion Resources in 2006
- Currently funded for part of Phase 1 at \$7.5 M
- Potential economic impact of \$7.5 million

#### **Proposed Development**

Revenue Generation

60-site campground 20 cabins, boat ramp, canoe-in camping

Infrastructure

Contact station, office/admin complex, maintenance facility, staff residences





### **Powhatan State Park**



- Originally opened in July 2013
- 30-site campground currently under construction that will include 4 yurts
  - Estimated completion date: August 2016
- Introduced budget provides funding for next phase of development to include some cabins (full cabin scope would be 20 cabins)
- Potential economic impact of \$600,000 with completion of campground: at full build-up, economic impact estimated at \$4.5 million



# **Clinch River**



- At request of the GA, a State Park study was conducted by DCR in 2005; updated in 2008
- 2015 GA authorized pre-planning for a Clinch River State Park
- Park is envisioned as multiple access points along the Clinch River (including existing public properties Cavitt's Creek Park, Pinnacle Natural Area, Cleveland Barrens Natural Area, Sugar Hill)
- As part of the pre-planning process, several parcels with willing landowners have been identified
- Advocacy group, the Clinch River Valley Initiative is leading the effort



# Natural Bridge State Park

- Originally bought by Virginia Conservation Legacy Fund (VCLF) in Spring 2014
  - \$9.1 million loan from Virginia Resources Authority
  - Current balance of loan is \$7.65 million
  - VCLF currently behind on payment but working to address delinquency





- \$120,000 proposed in FY2017 and FY2018 for opening Natural Bridge State Park
  - This is in addition to \$60,000 provided in FY2016
  - Will fund 2 positions on-site
    - Chief Ranger and Park Manager
- Working with Office of the Attorney General to develop a draft operating agreement
  - All gate receipts entered into a restricted account to pay outstanding debt service
  - Any additional revenue will be used for maintenance and operation costs
  - Would need to be authorized by General Assembly



## **Daniel Boone Interpretive Center**

- Budget language authorizes DCR to accept transfer of the Daniel Boone Wilderness Trail Interpretive Center upon completion of construction
  - Language is identical to what was approved by 2013 GA
  - 153 acres of land which would preserve Kane's Gap
  - \$450,000 for maintenance and operations provided by Scott County Economic Development Authority
  - Satellite facility of Natural Tunnel State Park
  - Estimated completion fall 2016

  - Natural Tunnel



Provide for additional hiking, biking, and equestrian opportunities
