# **REPORT OF THE SUBCOMMITTEE**

## **ON**

### **HIGHER EDUCATION**

Mr. Chairman and Members of the Committee:

Mr. Chairman, as I contemplated my remarks today, I was reminded of Winston Churchill when he said, “It is wonderful what great strides can be made when there is a resolute purpose behind them.” At the start of this Session Mr. Chairman, you indicated that higher education would be a priority. The Subcommittee recommendations reflect your direction and the continued “resolute purpose” of making our public colleges and universities affordable for Virginia families, accessible for Virginia students, and focused on improving their job opportunities.

With that in mind, Mr. Chairman, the Subcommittee recommends amendments that include the following:

- \$205.4 million to support affordable access and degree production;
- \$51.1 million for the community colleges to increase by over 19,000, the number of degrees and credentials in high-demand industry sectors across the Commonwealth;
- \$37.0 million to complete the merger of Old Dominion University and the Eastern Virginia Medical School;
- \$83.2 million for improvements to financial programs and policies; and,


- \$10.0 million for an innovative partnership between our public and private Historically Black Colleges and Universities (HBCSs) that will support minority small business, health outcomes for marginalized populations and increasing access and opportunity for students.

In addition, Mr. Chairman, the Subcommittee recommends the restoration of \$75.0 million that was provided as part of the 2023 budget actions in Chapter 1 and removed in the introduced budget. The Subcommittee also recommends the restoration of \$3.1 million for the New College Institute.

Finally, Mr. Chairman, the Subcommittee would like to thank you and Delegate Willett for your leadership and support in providing a faculty salary increase for the next two years. Higher education remains a labor-intensive enterprise and these funds along with our other recommendations will provide our institutions with the ability to attract and retain talented faculty.

Mr. Chairman, details of our Subcommittee recommendations are attached. Committee staff will review our report and the attached listing of our recommendations in greater detail, and I hope that it will be the pleasure of the Committee to adopt them.







The funding is designed to expand paid or credit-bearing student internship and other work-based learning opportunities (internships) in collaboration with Virginia employers. In furtherance of the goal of providing all postsecondary students in Virginia with one or more paid internships during their undergraduate course of study, funding shall be used for: (a) institutional grants to enhance engagement with employers related to internship placement and to assist students in securing and successfully completing internships; (b) matching grants to small and midsize Virginia-based employers to enable increased paid internship participation by small and midsize businesses and nonprofit organizations; (c) promotional expenditures to encourage expansion of internship programs and participation by business and nonprofit organizations in Virginia and to increase recruitment and retention of students; and (d) administrative and other expenditures to accomplish the purposes of the Innovative Internship Fund and Program and this paragraph

2. Institutional grants shall be awarded to support initiatives that are expected to produce significant increases in student participation in paid and credit-bearing internship programs. Institutions shall be eligible for grants upon demonstrating (a) that it is a bona fide priority of the institution and its senior academic and administrative leadership to expand internship participation by students, to incorporate internships in curricula, and to report completion of internships and courses that include internships on student transcripts, and (b) that the institution has put forward an achievable plan to advance such priority, including the allocation of resources and assignment of dedicated personnel to facilitate placement of students in internships and to engage with employers directly or through intermediaries for the purpose of developing internship opportunities. In determining the amount of grant awards, the Council shall consider the number of undergraduate students enrolled at the institution, the number of

students at the institution who participate in internships, and the numerical and percentage increase in internship participation expected to result from the initiative. In addition, the Council shall increase grant awards based upon the following factors: (i) an institution's emphasis on internships that are part of pathways to full-time employment with Virginia-based employers; (ii) the institutional initiative's alignment with specific state or regional programs or partnerships related to economic growth and diversification or workforce development in Virginia; (iii) an institution's strength of commitment as reflected in its reallocation of institutional funds or solicitation of philanthropic support or business partnerships to support the initiative. This funding is intended to be recurring for institutions that demonstrate substantial yearly progress in achieving the objectives of the initiative as measured by the number of internships successfully completed by students.

3. Matching grants to small and midsize Virginia-based employers that provide paid internships shall be awarded by the Council according to criteria established by the Council in consultation with the Virginia Department of Workforce Development and Advancement, Virginia Economic Development Partnership, and the Virginia Talent and Opportunity Partnership. Such criteria shall include: (a) limitation of eligibility to for-profit businesses and nonprofit organizations, excluding institutions of higher education, with physical operations and facilities in Virginia and 150 or fewer Virginia-based employees; (b) certification of employer eligibility by the Council following a training program of reasonable duration and agreement by the employer to reasonable mentoring and reporting obligations; (c) limitation of grant awards to reimbursement, not to exceed \$7,500 per internship, for a maximum of one-half of wages, including FICA, and workplace subsidies, including transportation, housing, and other internship-related expenses, paid to or for the benefit of a student participating in a qualifying internship; (d) definition of a qualifying internship as a paid work-based learning experience of a duration, not to exceed twelve months, sufficient to allow the student to gain significant valuable work experience that is provided to a student currently enrolled in, or having received a degree or credential within the preceding twelve months from, a public or private institution of higher education operating in Virginia; (e) limitation of qualifying internships to a number not to exceed four internships annually per eligible employer. Funding may also be used to support staffing agency services related to intern recruitment for employers with 250 or fewer Virginia-based employees that are otherwise eligible for matching grants under this paragraph, provided that no employer shall be required to receive staffing agency services as a condition to eligibility for matching grants.

4. The Council, with and through the Virginia Talent and Opportunity Partnership, and in consultation with the Virginia Department of Workforce Development and Advancement, Virginia Economic Development Partnership, the Virginia Growth and Opportunity Board, public and private institutions of higher education, and business and nonprofit organization stakeholders, shall develop and execute a promotional plan to raise awareness and foster expanded internship programs and participation by business and nonprofit organizations in Virginia using a combination of public and private resources. The plan shall highlight the Commonwealth's goal to provide paid internship opportunities to all postsecondary students and shall provide for public recognition of employers based on their level of participation in

internship programs. The plan shall include continued development of regional collaboratives among employers, educational organizations, and other regional stakeholders for the purpose of expanding internships in alignment with regional growth and diversification strategies and state and regional economic and workforce development initiatives. The plan also shall address the objective of encouraging secondary students in Virginia and outside Virginia to attend Virginia-based institutions of higher education and remain in the Commonwealth after completion through paid internships and pathways to full-time Virginia-based employment.

5. In administering the program authorized in this paragraph, the Council shall (i) engage stakeholders from business and industry, secondary and higher education, economic development, and state agencies and entities that are successfully engaging employers or successfully operating internship programs; (ii) explore strategies in Virginia and elsewhere on successful institutional, regional, statewide or sector-based internship programs; (iii) gather data on current institutional internship practices, scale, and outcomes; (iv) develop internship readiness educational resources, delivery methods, certification procedures, and outreach and awareness activities for employer partners, students, and institutional career development personnel; (v) pursue shared services or other efficiency initiatives, including technological solutions; and (vi) create a process to prioritize industry sectors and track key measures of performance in collaboration with the Virginia Office of Education Economics."
