### FY09 Budget Overview - as of July 1, 2008

Category	Budget	Percent of Total Spending	
Salary & Benefits	\$57,114,991	65%	
VITA	\$11,104,273	13%	
Wage & Contract Employees	\$8,589,981	10%	
Printing, Postage, Rent, & Compliance Travel	7,246,869	8%	
All other (Hardware & Software Maintenance, Insurance, etc)	\$3,701,948	4%	
Chapter 879	\$87,758,062	100% 3	

## **Recent Budget Reductions**

- Total Reductions in FY08 FY09 = \$9.2 Million
  - \$5.5 Million in FY 2008
  - \$3.7 Million in FY 2009
- Between FY 2004 FY 2007, budget was reduced by \$5.4 Million for "VITA Savings"
  - However cost have remained consistent
  - Also additional \$685,802 reduced in FY08

## **Compliance** Initiative

#### Revenue Impact

- New Revenue of \$23 Million by FY10
- New Revenue of \$80 Million by FY12

#### • Source of Revenue

- Expand current Desk Audit programs
- Implement new Initiatives
- Expand collection efforts for both Business and Individual Accounts

#### • Hire 55 New Employees

- 42 Employees have been hired
- All employees will be hired before June 30, 2009
- Cost \$1.2 Million in FY09 & \$4.6 Million in FY10

### Renovation & Move Funding

### • Special Session – April 2008

- Authority for DGS to purchase MSC
- Authority for DGS to build a new Tax Processing building on the land at 2220 West Broad Street
- Will relocate all employees currently at our 2220 building to MSC
  - Will cost \$2 Million
  - Cost estimates prepared by DGS, VITA, TAX, and a professional architectural firm (Ballou, Justice, and Upton).
