

Local-Responsible Prisoner Population Growth





FY2008 Forecast Vs. Actual




Offenders in Jail Awaiting Trial* on Felony Charges



^{*} Data include offenders awaiting trial and those who have been sentenced for an offense but have additional charges pending.

- The number of defendants in jail awaiting trial on felony charges peaked in September 2006.
 - The majority of the growth in the local-responsible jail population in FY 2006 was attributable to the rise in the number of defendants in jail awaiting trial or pending additional charges.
- While there is typically a drop in November/December each year, this population declined through April 2008 before it rose again.

Forensic Analysis Caseload and End-of-Year Backlog




- A backlog of forensic evidence to be analyzed may result in defendants being held in jail for longer periods awaiting trial.
- The growth and decline in the case backlog was due primarily to drug cases.
 - Between FY 2003 and FY 2006, the drug case backlog increased 371%, while the backlog for all other cases combined increased 30%. Between FY 2006 and FY 2008, the drug case backlog decreased by 90%, while the backlog for all other cases combined decreased 30%.

Adult Local-Responsible Forecast

(FY Average)



Following substantial growth of 7-8% in FY 2006 and FY 2007, the average local-responsible jail population declined in FY 2008 by 1.7%.

- The overall decline in the local-responsible jail population in FY 2008 has resulted in a lower forecast than the one submitted in 2007.
 - The FY 2008 forecast projected that the population will increase by an average of 2.1% annually through FY 2014.
 - The FY 2007 forecast projected an increase by an average of 4.8% by FY 2013.



- Given the slower growth in FY 2008 compared to the previous fiscal year, the forecast approved this year is lower than the one submitted in 2007.
 - The FY 2008 forecast projected that the population will increase by an average of 2.3% annually through FY 2014.
 - The FY 2007 forecast projected an increase by an average of 2.8% by FY 2013.

Adult State-Responsible Forecast



Juvenile Detention Home Forecast


(FY Average)



- Between FY 2001 and FY 2008, the juvenile detention home population decreased 7.3%. The juvenile detention home population decreased by 4.7% from FY 2007 to FY 2008.
- It is projected that the population will decrease by an average of 0.9% annually through FY2014.

Juvenile Correctional Center Forecast

(June Average)



- Between FY 2001 and FY 2008, the juvenile correctional center population decreased 24.9%. The juvenile correctional center population decreased by 10.6% from FY 2007 to FY 2008.
- It is projected that the population will decrease by an average of 1.8% annually through FY2014.
