





FY14 - Service Highlights

- Filed 23,241 disability compensation claims on behalf of Virginia veterans and families, directly enabling the recoupment of <u>\$2.3 billion</u> in federal compensation and disability payments to our veterans in FFY13.
- Facilitated the employment of 3,225 Virginia veterans through the Virginia Values Veterans (V3) Program.
- Approved 1,122 educational program offerings for the G.I.
 Bill program, thus expanding educational opportunities for
 veterans using their G.I. Bill benefits. Virginia veterans
 received more than \$872 million in G.I. Bill benefits in FFY13.



FY14 - Service Highlights

- Provided 130,670 patient days of care at the Sitter & Barfoot Veterans Care Center (Richmond) and the Virginia Veterans Care Center (Roanoke).
- Performed 1,464 burials at Virginia's three state veterans cemeteries (Amelia, Dublin, and Suffolk).
- Delivered 5,606 discrete supportive services to veterans and their families through the Virginia Wounded Warrior Program.
- Honored Virginia's fallen by hosting 65,692 visitors at the Virginia War Memorial, a new single-year record.



Benefits Services

- \$1,750,201 (GF) in new funding in FY2016
- With the new funding, DVS will:
 - Add five positions at understaffed offices
 - Convert 13 administrative positions to veterans service representatives
 - Implement a career development plan for all staff to strengthen recruitment, hiring, training, and retention
 - Open two new benefit offices in underserved areas



Homeless Veterans

- \$180,000 (GF) in new funding for DVS in FY2016
- With the new funding, DVS will hire three local Housing Resource Specialists in Northern Virginia, Southwest Virginia, and Greater Hampton Roads



Employment and Transition

 Create new sub-program 46703 and establish appropriations for the Virginia Values Veterans (V3)
 Program and the Virginia Transition Assistance Program (VTAP)



Employment and Transition

- V3/VTAP: \$474,000 (GF) and \$100,000 (NGF) in new funding in FY2016
- With the increased funding, DVS will:
 - V3 Program: expand outreach and training for V3 companies hiring veterans
 - VTAP: expand direct outreach to transitioning servicemembers and military bases to facilitate employment, training, and education in Virginia
 - NGF appropriation will support donations received toward V3 and VTAP.



Education

- Increased funding allows expanded access to post-secondary education under the federal G.I. Bill program and the state Virginia Military Survivors and Dependents Education Program (VMSDEP)
- VMSDEP: \$67,090 (GF) in new funding and 1 FTE in FY2016
- G.I. Bill Program Certification: \$42,000 (NGF) in additional funding (federal contract)



Veterans Care Centers

- Increases state commitment of project costs (35%) to:
 - \$32,640,481 (Hampton Roads) and
 - + \$33,912,198 (Northern Virginia)
- With the commitment of the higher level of state funding,
 DVS will request a higher level of federal funding for the projects



Veterans Cemeteries

Authority for DVS to apply for federal grant funding (100% of project costs) to add burial sites at the state veterans cemetery in Suffolk
