
# Overview of VPI+



More than 10,000 Virginia children across 13 communities have benefited from VPI+, including 1,500 children who are currently in VPI+ slots.

Thirteen divisions currently offer 1,522 VPI+ (slots in parentheses):

- 1. Brunswick (22)
- 2. Chesterfield (208)
- 3. Fairfax (87)
- 4. Giles (36)
- 5. Henrico (360)
- 6. Norfolk (142)
- 7. Petersburg (72)
- 8. Prince William (208)
- 9. Richmond City (116)
- 10. Sussex (24)
- 11. Winchester (103)
- 12. Frederick (54)
- 13. Virginia Beach (90)







## More Than Two-thirds of VPI+ Children are Ready for Kindergarten




Note: Measures for kindergarten readiness differed slightly between children who attended VPI+ and children who did not attend VPI+. Kindergarten children who did not attend VPI+ group includes 21,944 children from 64 school divisions (see Williford, Whittaker & McGinty "Presentation to Virginia's Children's Cabinet" November 13, 2018)

## **VPI+ Successfully Implemented Key Components of Quality Preschool**

#### Developmentally appropriate classrooms

- Child-to-adult ratios of no more than 9 to 1
- Class sizes of no more than 18 children
- Evidence-based curricula
- Full-day (5.5 hours per day)

#### Well trained and compensated teachers

- Nearly all teachers (99%) have a bachelor's degree and 53% have a masters degree or higher
- Salaries commensurate with local kindergarten teachers

# Ongoing observation and feedback

- 3 hours of coaching per month
- At least 1 CLASS observation every other year (some more frequently)
- Regular training on:
  o curriculum
  - classroom organization & management
  - teacher-child interactions
  - o use of assessments

#### Supports for children outside of the classroom

- On-site vision and hearing screenings, mental health, and adult education
- Referrals to additional community-based services

These are similar components to VPI classrooms under November 2018 Plan.

# Where Do We Go From Here



More than 10,000 Virginia children have benefited, schools and teachers have built capacity and families are overwhelmingly positive about VPI+.

- Virginia communities and families want to sustain slots in order to ensure more children enter school ready for success.
- VPI+ classrooms are already implementing the VPI plan, serving as a model for others:
  - Using integrated, evidence-based curriculum
  - Regularly assessing and improving teacher-child interaction quality (*CLASS* ratings)
  - Providing individualized, data-driven professional development
- Virginia can continue to fund these slots, potentially at a lower amount per child, to help these communities prepare children for kindergarten.
